

Table 1 Employment settings and roles of medical toxicologists

Settings	Role
Emergency departments, intensive care units, and other inpatient units	Direct treatment and bedside consultation of acutely poisoned adults and children
Outpatient clinics, offices, and job sites	Evaluate the health impact from acute and chronic exposure to toxic substances in the workplace, home, and general environment
Regional poison centers	Provide advice to other health care providers as well as laity
Medical schools, universities, and clinical training sites	Teach, research, mentor, and provide advanced evidence-based patient care
Industry and commerce	Contribute to pharmaceutical stewardship, research, and drug safety
Government agencies, such as the Centers for Disease Control and Prevention and the Food and Drug Administration	Direct health policy, help other physicians prepare for dealing with the aftermath of crimes such as chemical and biological warfare, and engage in emergency preparedness and response
Clinical-and forensic-laboratories	Analyze and interpret critical toxicological data





- Objective: **evaluate the potential economic and clinical benefits** of medical toxicology services
- Broad scope of services: **inpatient, outpatient, telemedicine** all eligible
- Outcomes may be **clinical** and/or **economic**; detailed list of possible targets in RFP
- **Not** intended to support evaluation of interventions or services conducted by a **Poison Center**



MTF Practice Grant

Up to \$10,000

Up to 2 awards

One year: July 2026 – June 2027

- PI must be **ACMT member**
- **Trainee** PI: must have ACMT member mentor
- Plan **carefully** for career transitions
- Present abstract at ACMT **ASM**
- Progress reports at mid-point and end of grant
- IRB approval prior to *disbursement of funds*
- Does not fund investigator time, salary support, travel, institutional overhead, or personal hardware

Award Overview


Purpose

The Medical Toxicology Foundation funds projects that support the Foundation's mission to advance research and education in the prevention and treatment of patients adversely impacted by drugs, chemicals, and natural toxins. Therefore, the MTF is offering up to \$10,000 to fund research evaluating the potential economic and clinical benefits of medical toxicology services.

Scope

The practice of Medical Toxicology increasingly involves the provision of clinical care directly to patients, including bedside evaluation in the acute care setting, outpatient clinic visits, and telemedicine consultations. The MTF wishes to assist in promoting these services to leaders and stakeholders in hospitals, healthcare systems, non-profit organizations, and governments.


